TERMS & CONDITIONS

MAJOR TERMS AND CONDITIONS

1. The rent amount includes Staying, Housekeeping, Food charges & laundry.
2. At the time of admission 2 month rent has to be deposited in advance, out of which 1 month rent will be adjusted in current month.
3. Caution Money will remain deposited till the date of leaving Room by the student and will be refunded to student or his parents at the time of leaving room after deducting Residency dues and any damages done in Room. Caution money cannot be adjusted with room rent.
4. Student is required to pay rent for minimum ten months or as per AFFIDAVIT whichever is higher otherwise all advance rent or deposit will be forfeited by management.
5. Electricity charges will be charged separately. It is excluded from the rent amount.
6. In case the student leaves the Residency before the completion of the contract period, the advance rent amount will be forfeited.
7. In case the admission is done before the 15th Day of the month, then rent for the whole month will be charged. This month will be included in the contract period. If the admission is done after the 15th day of the month, then the rent of 15 days will be charged, and these 15 days period will not be included in the contract period.
